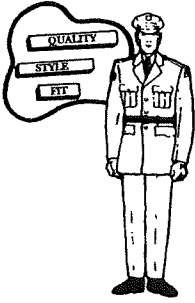

## **Exceptions**

### **Item 12A and 12B – Class C L/S Shirt and Class C S/S Shirt**

- We did not realize until recently that these were Red The Tailor custom items and Hope Uniforms will not be carrying the fabric to make these shirts nor do they have plans to offer it in their line.
- In lieu of the discontinued item for Item 12A, we are offering Blauer 8670 (L/S) which is a 100% Dacron polyester shirt in French blue
- In lieu of the discontinued item for Item 12B, we are offering Blauer 8675 (S/S) which is a 100% Dacron polyester shirt in French blue
- Blauer shirts are not made in the USA.

### **Item 11 – Class C Trousers (8810X)**

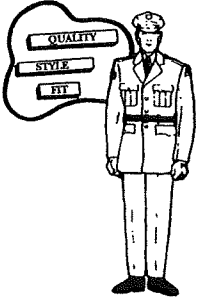
- Since we are offering Blauer shirts for Items 12A and 12B, we will obtain that shirt fabric to make the 1 1/8" striping required on this pant so that it matches with the Class C shirt we are proposing.

### **Item No. 7 and 8 – Port Authority Legacy Jackets**

- Please note that Port Authority has discontinued Millenium/Navy color in this jacket (both mens and ladies styles). The color options for this jacket are Black/Steel Grey or Dark Navy/Red.

### **Delivery Time Frame**

- As clarified by Addendum 1 – delivery time frame will be 60-100 days on custom items but could go longer due to fabric availability. Also as clarified by Addendum 1 – we cannot agree to any liquidated damages based on delivery time frame.

### **Items No. 1 thru 4 – Uniform Dress Blouse, Class A-B Trousers, and Class A-B Shirts**

- Please note that Howard Uniform is utilizing Hope Uniforms as the supplier for made to measure garments. - Howard Uniform has the in-house capability to make custom trousers and custom dress blouses, however, we do not offer custom/made to measure shirts. For consistency, we will be utilizing Hope Uniforms for all Uniform Dress Blouses, Class A-B trousers, and Class A-B Shirts. We fully expect that Hope Uniform made to measure products will meet your approval. However, if for any reason they do not, then we can offer you Howard Uniform samples for blouse coats and trousers only and will have to present you with stock shirt options from other uniform brands.

### **Item No. 2 – Class “A-B” Trousers**

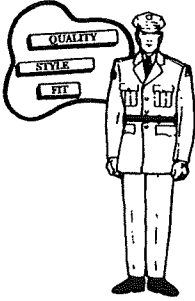
- Add \$20 per trousers if the optional route book cargo pockets (stated on page 25 of the specifications are required).
