PB1. Welcome/Introductions:

- Meeting Attendees were asked to submit their contact information in either the *TEAMS* chat section or email me directly at ecbidquestions@washco-md.net. Attendees were asked to provide their Name, Company, Email Address & Telephone Number.
- Attendees were notified that Meeting Minutes will be distributed following this meeting.

PB2. Project Overview:

- Professional Boulevard Phase III & IV project work is described as the final portion of new roadway construction between Yale Drive and Isaac Court. This roadway will complete the connection of Professional Boulevard from Eastern Boulevard to Robinwood Drive.
- The project will construct the last section of Professional Boulevard with approximately 1650 LF of new roadway from the east leg of the roundabout with Yale Drive to Isaac Court in the Rosewood subdivision. The closed section roadway will have 2 lanes in each direction and planned entrances on each side of the roadway with center left turning lanes. There will be an 8-foot concrete shared use path and concrete pads for future bus shelters. Filter inlets, grass, and bioswales will be used for stormwater management. Other items include grading, storm drains, a modular block retaining wall, a section of 12" waterline, asphalt paving, striping to include removal and restriping of the roundabout and signage.

PB3. Project Classification:

This Project Classification is Cost Group Letter Class "E", \$2,500,001 to \$5,000,000.

PB4. Time of Completion and Liquidated Damages:

This is a 325 consecutive calendar day contract. Liquidated Damages are in the amount of \$500.00 per day for each consecutive calendar day beyond the contract end date.

PB5. Notice to Proceed:

The proposed Notice to Proceed is anticipated to be issued in May 2025, and the proposed completion date is March 2026. Refer to Bid Document item ITB 1.10 for further detail.

P6. Special Site Conditions:

- A NOI and SWPPP have been submitted for the project, and approval is expected prior to the award of the contract.
- When Yale Drive was constructed, the excess suitable fill was placed and compacted between station 3+00 and 10+00. This is reflected in the existing grades. Contractors should note that this should reduce the amount of grubbing needed and topsoil present within this section of the roadbed.
- Prior construction for the adjacent cell tower ran an electric line within the 10' utility easement on the north side of the roadway. Planned grades were provided at the time, and much of the area is to be filled. There is a cut section between station 10+50 and 13+00 where care should be taken. There is an item for test pitting if needed.
- There is an existing electric vault next to the road which belongs to CHIEF and was an extra from Yale Drive. We are working with CHIEF and Potomac Edison to determine what is to be done with it, and an item may be added by addendum to either move it to another onsite location or set it for future hook up.

PB7. Material Testing:

Contractors are required to provide field and laboratory testing of materials used for construction, including concrete, soils, aggregates, and asphalt. Refer to the Bid Document, pages TP-2 through TP-4 for further detail.

PB8. Bid Questions:

Bidders are advised that the deadline for submitting questions is Friday, March 14, 2025, at 4:00 PM. Bidders may send questions via email, or submit questions through the County's online bidding portal. The email address is ecbidquestions@washco-md.net.

PB9. Bid Due Date & Location:

• There are now two ways to submit bids, traditionally and via the County's new bid portal. The County's new bid portal is in operation and will allow bidders to electronically submit their bids through the portal. Bidders should make themselves aware of the bid portal and the functionality of the platform. Registration to the portal can be accessed using the link provided in the bid document (https://washco-md.net.ionwave.net).
