Fiscal Year 2024, Charitable Gaming Report Washington County, Maryland

Overview

Washington County's Charitable Gaming Program continues to have a significant impact on small businesses, veterans organizations, fraternal clubs and charities in Washington County.

This funding has been used to feed the hungry, provide healthcare to the uninsured and underinsured, fund after-school programs, provide public safety, educate the developmentally disabled, treat veterans with traumatic injuries, provide mental health services, and to allow our youth to engage in recreational activities to combat obesity, in addition to many other worthy causes.

Equally important is the fact that Washington County's Charitable Gaming Program continues to be a source of significant income for small businesses whose participation in the program is vital to its success. This income allows small businesses to prosper and employ Washington County citizens. The program also allows fraternal and veterans organizations to fulfill their philanthropic obligations and provide services to the disadvantaged or those returning from military service.

It should be noted that 100% of the funding provided, and the administrative costs associated with the program are paid by those choosing to participate in the program. This program is operated at absolutely no cost to the Washington County taxpayer unless they choose to participate.

State law requires funds be divided equally between the Washington County Fire and Rescue Association and local charities.

In fiscal year 2024, Gaming Fund revenues collected totaled \$2,414,285.89 representing a decrease of \$128,744.45 when compared to fiscal year 2023 revenues.

With the direction, oversight, and support of our state and local elected officials, and an uncompromising policy of open and transparent accountability, our charitable gaming program continues to be revered as a model charitable gaming program that will continue to provide a financial lifeline to Washington County charitable organizations and provide economic benefit to the County and its citizens for many years to come.

Gaming Fund Allocations

Washington County's Charitable Gaming Program funded 61 requests for funding in fiscal year 2024. On August 6, 2024, the Washington County Gaming Commission announced the distribution of \$2,414,285.89 to local charitable organizations and the Washington County Volunteer Fire and Rescue Association. This year's total represents a decrease of \$128,744.45 when compared to fiscal year 2023 revenues.


